In accordance with Securities and Futures (Client Money) Rules (Cap. 5711), I / we hereby authorize New Region Securities Limited ("NRSC") in its sole discretion to do any of the following things, without any prior notice to us or any instruction or confirmation from us:

 to combine or consolidate any or all segregated accounts, of any nature whatsoever and either individually or jointly with others, maintained by NRSC on behalf of me / us and transfer any client money to and between such segregated accounts in order to satisfy any obligation or liability owed by me / us to NRSC, whether such obligation or liability are actual or contingent, primary or collateral, secured or unsecured, or joint or several:
