Pursuant to Securities and Futures (Client Securities) Rules (Cap. 571H), I / we hereby authorize New Region Securities Limited ("NRSC") in its sole discretion to do any of the following things, without any prior notice to us or any instruction or confirmation from us:

- 2. to deposit any of my / our securities collaterals with an authorized financial institution (as defined in the Banking Ordinance (Cap. 155)) as collateral for financial accommodations provided by such institution to NRSC;

- to deposit any of my / our securities collaterals with Hong Kong Securities Clearing Company Limited ("HKSCC") as collaterals for the
 performance of NRSC settlement obligations and liabilities (it being understood that HKSCC will create the first fixed charge over my /
 our securities collaterals in accordance with CISI's obligations and liabilities);
